Regarding Organizing Various Programmes/ Activities in the Schools Resulting Wastage of Precious Hours School Studies-Instructions, thereof.

On the above mentioned subject, it has come to the notice of the Government that various programmes/ activities through various Departments/ NGOs/Local public are being organized in the Schools. This practice is hampering the studies of the Students and makes it difficult to provide necessary teaching hours to the Students and complete their syllabi well in time. The Hon'ble High Court has passed the orders in CWPIL No. 146/2017 on 11-12-2017 as under:-

"we further direct that no activity other than the one connected with the affairs of the Institution shall be carried out in any of the campuses, meant for imparting teaching to Students, be it a Primary, Secondary, Higher or College levels. The Principal(s) of such Institutions are directed to ensure that activities conducted by the concerned Student Unions are not carried out in a manner so as to be detrimental to education or interest of the Students"

In view of above mentioned, you are directed to comply with the directions/ orders of the Hon'ble High Court in letter and spirit and to avoid such activities strictly in your School/ College premises. And if any such programme /activity are anyway beneficial/ necessary for the Students, the prior permission / approval of this Directorate may be obtained unflinchingly.


