**Subject: - Regarding strict Prohibition on Caste based discrimination in Educational Institutions in Himachal Pradesh.**

As you are aware that despite several instructions issued from the department of education regarding the prohibition and discouraging of any discrimination with the students of the schools on the basis of religion, caste, creed and gender especially while serving the Mid Day Meal (MDM). Some incidents of discrimination with the school children on the basis of afore-mentioned factors are still reported from various places. In this regard, it is therefore, once again very forcefully reiterated that such type of discrimination should be completely stopped. Extra precautions should be taken so that such bad practices are totally stopped. Mid Day Meal Programme must be used as a vehicle for inculcation of good habits, discipline and spirit of social equality among school children while serving MDM to them in the schools. MDMS guidelines also stipulate that the community members, teachers and authorities of the department must ensure that children must eat Mid Day Meal together in an orderly manner strictly on Roll Number basis in a spirit of camaraderie in the schools without any discrimination on the basis of religion, caste, creed and gender. If any Government official/ public or any other person is indulged and found in such kind of act of discrimination the matter will be viewed very seriously and stern action will be initiated against the erring government officials/ persons as warranted under the law.

The necessary instructions may be issued to all the school under your control regarding the prohibition of discrimination with children on the basis of religion, caste and creed etc. and to keep very strict vigil regarding this. If the incidents of discrimination are reported, the same may be reported to this Directorate immediately without any delay in the matter.

Students, Parents and public in this regard should be sensitized accordingly.

This may be treated as most urgent and personal attention be given in the matter. Action taken report regarding the matter be submitted at the earliest.

Sir,

Kindly refer to your office letter No. HR(E-3)B(15)2012-13-162325-26 dated 29.11.2019, on the subject cited above.

In this regard, it is informed that a case FIR No. 95/19 dated 19.09.2019 U/S 3(1) (r) (s)(u) and Sec. 3 (2)(vii) of SC/ST (POA) Act was registered in Police Station Gohar on the complaint of Sh. Dharam Chand S/o Sh. Debu Ram R/o Village Dahar, PO Sukkibain, Tehsil Chachiot, District Mandi, & other that the Block Level Sports Tournaments were organized at Govt. Senior Secondary School, Kiling, District Mandi. On dated 09.09.2019, the midday meal workers Smt. Chhama Devi and Smt. Rajani Devi has made discrimination with the children of scheduled caste for serving water and food during this tournament.

The investigation of this case has been conducted by Sh. Manav Verma, IPS, Assistant Superintendent of Police, Mandi. During the course of investigation spot inspection has been done on the instance of the complainant, statement u/s 161 Cr. PC of eyewitnesses have been recorded. The allegations leveled in the FIR have not been substantiated for which the **Cancellation Report** u/s 173 Cr. PC has been prepared by the investigating officer in which legal opinion has also been obtained from District Attorney Mandi accordingly and sent to District level vigilance & Monitoring Committee Mandi for final approval on 16.11.2019.
