Subject:- Regarding mainstreaming of out of school adolescent girls, enrolment of only 5+ age group in Government Primary Schools and Adjusting Anganwadi Centres in the compounds of nearby GPSs.

Sir / Madam,

Your kind attention is invited to the aforementioned subject. In this regard, it is informed that there had been an important meeting in the chamber of Additional Chief Secretary (Education), Government of Himachal Pradesh on 04-08-2017 at 2.00 P.M. The meeting was chaired by the ACS (Education). The main points of discussion were as under:-

1. Mainstreaming of out of school adolescent girls
2. Enrolment of only 5+ age group children in Government Primary Schools
3. Adjusting Anganwadi Centres in the compounds of nearby Government Primary Schools.

Against each item of discussion, following decisions were taken in the meeting:-

Mainstreaming of out of school adolescent girls

It was decided that in order to track each out of school girl child, State Project Office (SSA/RMSA) will take care of such 6-16 age group population whereas 17-18 age group shall be looked after by the Director, Higher Education, H.P.


Enrolment of only 5+ age group children in Government Primary Schools

It was pointed by the Officer of the Department of Women and Child Development that GPS Kandrou, District Bilaspur has two children of the age of 3.5 and 4 years respectively. The data also reveals that there are around 1434 children of below the age of 5 enrolled in different primary schools across the State. It was decided that only 5+ age group children be enrolled in government primary schools and the enrolment of children below 5 years of age in the AWs, is the mandate of the Department of Women and Child Development.

Adjusting Anganwadi Centres in the compounds of nearby Government Primary Schools

All the Anganwadi Centres must be co-located in the compounds of nearest Government Primary Schools, so that there is an easy access to every child to get herself / himself enrolled in that nearest school. This will enhance the entry rate in the first grade of each school and may show increasing trends in the enrolment in the years to come.


You are, therefore, directed to ensure compliance in the matter as per the directions given by the Additional Chief Secretary (Education) Government of Himachal Pradesh.
