As you are aware that the Government of Himachal Pradesh has made mandatory for all the educational institutions in the state to run Scouting activities. So, the Units must be registered every year with The Bharat Scouts and Guides, Himachal Pradesh (beware of the associations with similar names).

The Annual Group Registration for schools for the year 2024-25 is to be done by the District Association till 30-06-2024 and a consolidated report along with the transaction details of the total fee is to be sent to the State Headquarters on or before 20-07-2024 in the attached MS Excel Sheet.


