

Please find enclosed herewith a copy of letter No. CPCR-A(4)-2/2018-160-
161 dated 06-02-2019 received from Director WCD-Cum-Member Secretary, Commission for
Protection of Child Rights, Himachal Pradesh, Shimla-171009 on the subject cited above.


In this connection, it is informed that the Corporal punishment in any form,
for any reason, is totally banned. No student of a school shall be subjected to physical
punishment, mental harassment or discrimination of any kind. Who so ever contravenes this
provision shall be liable for strict disciplinary action under the service/conduct rules applicable to
such a person. The Head of the Institution shall enquire into the matter suo-motu as and when
such instance of physical punishment, mental harassment or discrimination of any kind comes to
his/her notice and if such enquiry reveals that the allegations have substance, the matter with the
enquiry report shall be sent to the Director/Deputy Director of Higher Education of the concerned
district who shall take appropriate departmental action against the defaulter. Ban on corporal
punishment shall also be in accordance with the provisions contained in Section 31 (3) of
National Commission for Protection of Child Rights (NCPDR).

Therefore, you are hereby directed to issue necessary ^{and} strict directions/order to
all Principals/Headmasters of Government as well as Private Schools working under your
jurisdiction to sensitize the teachers to avoid corporal punishment being given to the children in
schools.

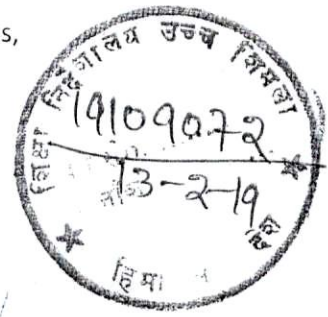
