In this connection, you are hereby directed to go through the Act,  
1997 (copy enclosed) it is clearly mentioned in the Himachal Pradesh Private  
Educational Institution (Regulation) Act, 1997 at Chapter-II, Clause 3 (a) & (b) and  
4(1) the no Private Educational Institution shall be established without the  
permission of the competent authority and the manager of every Private  
Educational Institution in existence on the date of commencement of this  
Act and every private educational institution proposed to be established  
on or after that date, shall make an application to the competent  
authority for permission to run such institution or to establish such  
institution, as the case may be.



Chapter-III clause (10) and (11) envisages that the account of  
every Private Educational Institution shall be maintained in the manner  
prescribed and shall be audited at the end of every academic year by a  
Chartered Accountant and the manager shall, within six months after  
the end of the Academic year, submit to the competent authority the

**report of such Chartered Accountant on the audit of the accounts under sub-section (1). But no such reports are being received in this office.**

Further you are hereby directed to supply the list of Private Schools running in your District without obtaining permission as warranted under the Himachal Pradesh Private Educational Institutions (Regulation) Act, 1997 from the Education Department till date and status of reports submitted by private schools as prescribed under Chapter-II clause (10) and (11). Further, you are also directed to inspect the Private Schools in your district at least once a year and submit a reports to this office regularly.

**The action in the matter may be taken on top priority basis. This information on must reach this office by 15th December, 2018.**


