Subject: - Clarification on grant of permission for felling of trees either causing danger to life and property or mandatorily required for developmental activities.

Sir,

It is to bring to your kind notice that many a times it is noticed that proper procedure for obtaining necessary permission for felling of trees either causing danger to life and property or mandatorily required for developmental activities are not being followed which creates un-necessary delay in disposal of such cases at various levels. As per instructions on the subject, such cases of tree felling on Govt. lands are required to be dealt as follows:

1. Trees falling in Municipal/NAC area (Non forest Govt. land)

Ref: Letter No. FFE-(B)F-13-53/2006-I dated 20th August, 2011 of Additional Chief Secretary (Forests) to the Government of Himachal Pradesh.

- Deputy Commissioner is competent to allow felling of trees in Municipal/NAC areas of State.
- Application to be submitted to Executive Officer, Municipal Council, Una/NAC who will forward the case to this office to verify the type, place and purpose of felling of tree.
- DFO after getting the facts verified through forest field staff send report to E.O.
- Joint Inspection of such trees is thereafter required to be carried out under the chairmanship of SDM as per Committee constituted by D.C. Una.
- Thereafter E.O. will submit the case to Deputy Commissioner for necessary sanction/accord felling permission.

2. **Trees falling in rural areas (Non-forest Govt. land)**

- * Applications received online are forwarded to concerned Range officer for spot verification and to upload his report/Joint Inspection report on the same online portal.
- * On receipt of online report from concerned RFO, case is forwarded to DFO and Conservator of Forests.
