This is with reference to the letter No. CPCR-A(4)-2/2018-1129 dated
10.12.2018 received from the Member Secretary, Commission for Protection of Child Rights New
Shimla-9 (photocopy enclosed), on the subject cited above. The Commission for Protection of
Child Rights has pointed that it is not appropriate to charge the school building rent from the
students. Further the Commission has directed such schools be found out in the State where school
building rent is being charged from the students and initiate necessary action to stop this practice by
providing Govt. Buildings.

In view of above, you are directed that list of such schools be found
out where school building rent is being charged from the students and submit the same to this office
within ten days positively, so that, necessary action could be taken accordingly.

This may be treated most urgent & given top priority.
