

ORDER

No. 113-153 /DRO/Relief-DDMA

Dated: 12-05-2022

Whereas district Una is adjoining the border area of Punjab and a large number of tourists/pilgrims, labour, daily commuters etc. come to district Una and several migrants workers from other states are moving in and out of the district and a strong likelihood of movement of anti-social elements across borders is ever present;

Whereas incidents of crime like thefts, jewellery and purse snatching, mobile snatching, eve-teasing, and vandalism etc. keep occurring in public places, which can be deterred using remote surveillance;

Whereas there are incidents being reported which pose a danger to national security and there is a need to boost security infrastructure in the District at once;

Whereas, there is an urgent need to prevent such incidents for the safety of general public and to prevent damage to public/private property it is necessary to have effective surveillance over all the public places or workplaces;

Whereas CCTV cameras set up at various places in the district to strengthen and monitor the law and order situation is an effective mechanism for prevention and detection of crimes, prevention of disasters and accidents.

Therefore, I, Raghav Sharma, IAS, District Magistrate, Una do hereby order and direct that:


- i.) The Head of Department, management/ persons-in-charge of every government building, panchayat ghars, municipal buildings, schools, colieges, other educational institutions (government/private), petrol pumps, liquor vends, industrial units/plants, hotels and religious places i.e mandir, masjid, gurudwara etc. shall install functional CCTV surveillance systems in the premises of all such places at their own level within a period of two months from this order.
- ii.) The CCTV surveillance system shall be installed as per the following specifications:
 - a.) all the entry and exit points and entire area of the premises of the place is covered through surveillance system.
 - b.) the CCTV camera at boundary shall be oriented to the area outside the boundary for checking suspicious movement.
 - c.) the CCTV camera shall have minimum 4MP HD quality resolution with night vision capability.
 - d.) at least 30 days CCTV feed shall be kept stored in hard disk of the surveillance system.

- e.) the CCTV surveillance system shall be kept functional continuously without any break by using power backup systems.
- f.) a nodal officer/ official/ person shall be identified by each institution to ensure proper functioning of the CCTV surveillance system.
- iii.) The CCTV surveillance system shall be kept open to inspection by the Sub-Divisional Magistrates, Tehsildars/ Naib Tehsildars and the police authorities as and when required. It shall be the legal responsibility of the management/ person-in-charge of the place to keep the CCTV surveillance system functional at all the times and in state of repair.
- iv.) There shall be a committee headed by the Sub- Divisional Magistrates in each sub- division and consisting of concerned Deputy Superintendent of Police, Station House Officer, Block Development Officer, Block Project Officers, Block Elementary Education Officer, Food Inspector, Excise Inspector, Extension Officer (Industries) and any other member to be co-opted by the Sub- Divisional Magistrate. Sub Divisional Magistrate shall call a meeting of the committee and map all the institutions within their jurisdiction falling in categories listed in paragraph (i). All these institutions shall be asked to install CCTV surveillance system of specification prescribed by police department and verification of installation shall be done through local departmental officers and local police.

The compliance of this order shall be ensured by all the Sub-Divisional Magistrates, Tehsildars/ Naib Tehsildars, Deputy Superintendents of Police and Station House Officers in district Una. In case any person/organization is found violating the aforesaid orders, the defaulting person(s) shall be proceeded against, as per the provisions of Section 188 of the Indian Penal Code, 1860.

This order shall come into force with immediate effect in the entire territorial jurisdiction of Una district.
