Subject: Police Verification of Drivers/Helpers of vehicles ferrying children to schools -reg

Sir/Madam,

In light of the various incidents of abuse of school-going children on the way to and back from schools, it has become necessary that all possible steps are taken to ensure safety of school children in their journey to and from the school. An important step in this regard would be to have police verification carried out in respect of the drivers and helpers etc. of bus/van/auto-rickshaw ferrying school children.

2. You are therefore requested to issue necessary directions to the schools in your State to ensure that staff are engaged for ferrying school-children only after police verification of their character and antecedents is completed. Moreover, with the passage of time, a person may be affected by many psycho-social factors in his immediate or distant environment. It would therefore be desirable that the police verification is repeated after every two years, so as to ensure continued safety of the children in their journey to and from the school.

3. All schools may be asked to strictly adhere to these instructions and stringent action be taken against the school authorities in case of any violation/lapse with regard to the safety and well being of school children.
