Subject: - Instruction regarding drug abuse.

Memo;

This is in continuation to letters issued by this Directorate from time to time regarding the burning issue of the Menace of Drug Abuse and to keep check on the same. You are once again hereby directed to issue necessary directions to all the Heads of Institutions (Government High and Senior Secondary Schools/Private Schools) to organize various types of activities to generate awareness about the Menace of Drug Abuse through Poster making, Slogan writing, Group Discussion, Declamation, Essay Writing, Poetry Recitation, Skit/Plays, Rallies related to ill effects of Drug Abuse. Some special lecturers or seminars on the subject of ill effects of drug abuse can be organized. Anti Drug Vigilance Committee/Anti Drug Force/Anti Drug Club/Societies should be functional in the Schools so as to carry out various activities related to awareness campaign against Drug Abuse. Record of the meetings and activities should be maintained in the institution.

You are also directed to organize health check up activities/camps in the schools with the help of health department so that the students indulging in Drug Abuse can be identified and can be given proper counseling with the help of health department. Some documentaries or short films related to ill-effects of drug abuse can be shown to sensitize the students and community about the menace of Drug Abuse.

Further, you are directed to issue necessary directions to all the heads of institutions to ensure the participation of students in Marathan/Rallies organized by the administration from time to time. The students may be sensitized regarding ill effect of Drug Abuse during the NSS/NCC Camps/Science activities/Tournaments, through lectures, IEC Material and Skits. During the General House of School Management Committee, this issue may

be discussed with the parents. It is also mandatory that there should be one Nodal Officer in each school responsible for the activities related to Drug Abuse. These instructions may be complied with letter and spirit since the State Government is very serious about this issue of drug abuse and moreover this is the responsibility of all including teachers/parents. Action taken reports regarding the activities conducted in the institutions be sent to this office and in case of any laxity concerned Controlling Officer/Head of Institution shall be held responsible and disciplinary action as warranted under rules shall be initiated against the official responsible.


