

Moreover, as per Rule 11 of the Notaries Rules, 1956, the notary may draw, attest or certify documents under his official seal including conveyance of properties, note and certify the general transactions relating to negotiable instruments, prepare a will or other testamentary documents and take affidavits for various purposes. Accordingly, you are advised to accept the documents duly attested by the Public Notaries unless specifically barred to be attested by Notary as well as also direct your field offices to accept the same. These instructions be adhered to strictly in letter & spirit and compliance be reported to this office.



Subject: Regarding authenticity of documents/instruments attested by the  
Public Notaries under rule 11(8) of the Notaries Rules, 1956.

Sir,

It is to inform you that during the inspection of the notarial record of the Public Notaries, Ld. LR-cum-Pr. Secretary (Law) was apprised by the various Public Notaries functioning in the State that affidavits and some other instruments attested by them are not being accepted by the authorities of the corporation/boards and banks in their Sub-Divisions/Districts. It has been told that due to non-acceptance of documents duly attested by the Public Notaries, people are compelled to prepare documents and get attested by the other attesting authorities. The appointment of Public Notary is a statutory appointment and he discharge his duty under the provisions of the Notaries Act, 1952 and rules made thereunder. As per rule 11 of the Notaries Rules, 1956, the notary may draw, attest or certify documents under his official seal including conveyance of properties, note and certify the general transactions relating to negotiable instruments, prepare a will or other testamentary documents and take affidavits for various purposes. In view of the above, a need has been felt to apprise all the District Magistrates in the State of the problem being faced by the people in general. You are, therefore, requested to issue appropriate instructions in this behalf to the authorities of the corporations/boards and banks to accept the documents duly attested by the Public Notaries unless specifically barred to be attested by Notary so that general public may not face difficulty in attesting documents time and again.
