In this regard, your attention is invited to the Government of India decisions No. 26, 26-A and 26-B read with Rule 3(1)(iii) of the CCS (Conduct) Rules, 1964 which provide that the Government servant will do nothing which is unbecoming of a Government servant and also to the para 8.5.1 of Office Manual, which provides that no member of the Department shall submit any letter/ representation direct to the Governor/ Chief Minister/ Ministers/ Chief Secretary/ Secretary/ Special Secretary/ Additional Secretary/ Joint Secretary/ Deputy Secretary/ Under Secretary or Head of the Department/ Office. All communications should be sent through proper channel.

Therefore, all the concerned officers/ officials i.e. Principal(s)(College & School Cadre)/ Assistant/ Associate Professor(s)/ Acharya (s)/ School Lecturers/ PGTs/ Ministerial staff/ etc. are directed to adhere to these instructions in letter and spirit and failure to observe these instructions shall be severely dealt with under the CCS (Conduct) Rules.

This may be given personal attention and all the concerned Officers/ Officials may be intimated accordingly.


