Sir,

I am directed to inform you that certain instances have come to the
knowledge of the Commission where P.I.O. and D.D.O. are not depositing the fee
charged by them under RTI Act 2005 in the Government Head of Account i.e. "0070
60-118-01 Receipt from Right to Information".

As per HPR.T.I. Rule 5 the fee charged under Act should be
deposited in the Government Head, but many P.I.O. are not encashing the I.P.O. and
Demand Draft lying with them and the same are either kept with the application file
after encashing deposited in some different Head of account.

Therefore, you are requested to kindly direct all P.I.O. and
D.D.O. under your control to adhere to Rule 5 of HP. R.T.I. Rules. Rule 5 (3) of
RTI Rules, 2006 mentions as follows:-

Comd./-

"Fees/charges shall be deposited in the Government Treasury under the head of account "0070- 60-118-01-Receipt head under Right to Information Act, 2005. Accruals into this head of account may be placed in a separate fund by way of grant-in-aid for furthering the purposes of the Act, including purchase of equipment and consumables, providing training to staff etc".

Further if required detail audit inspection may kindly be conducted of the respective offices.


