Sir/Madam,

As you are already aware that stitching charges @ ₹ 200/- per student (Boys & Girls) is provided to all the students of classes 1st - 10 for stitching of school uniforms under "Atal School Vardi Yojna" for which the requisite budget has been allocated to all the Identified Indenting Officers of the Department viz (BEEOs & Principal GSSS) vide this Directorate letter of even No. dated 01-08-2019 with the direction that the abovesaid payment of stitching charges be transferred directly in the Bank Accounts of the students.

In this context, various Indenting Officer's of the Department are informing that some students of classes 1st - 10th do not have Bank Accounts and due to this reason the payment of prescribed amount of stitching charges are not being transferred directly in the Bank Accounts of the students. In view of the above, you are therefore directed to carry out a special drive for opening Bank Accounts of all the left out students on priority and make the payment of prescribed amount of stitching charges to all the students electronically in their Bank Accounts in a time bound manner. The APR's and utilization certificates of the utilized amount may be sent to this Directorate, so that the same could be submitted to the quarter concerned, however, it may be ensured that no students are left without payment of the prescribed amount of stitching charges for school uniforms under "Atal School Vardi Yojna". Action taken(ATR) may also be furnished to this office accordingly.

This may be treated as most urgent, top priority and time bound.
