

Subject: Corrigendum to "Manual on Safety and Security of Children in Schools".

All the stakeholders using the above mentioned Manual are advised to keep the following modification:


Page 43-44, Sl. No.-VIII of part 2 of Bullying, Intimidation and Isolation, Section-III namely "PSYCHO-SOCIAL ASPECTS" available on website of NCPCR.

I. "Comprehensive guidelines may be developed for School Management which includes the various actions and penalties which may be taken by the School Management as per observation and understanding the gravity of the misconduct"

May be read as *

"Comprehensive guidelines may be developed for School Management which includes the various mechanisms for the positive engagement of children."

II. "Some of the recommended actions include: a. Oral/written warning. b. Suspension from attending classes/school for a specified period. c. Withholding or cancelling the results. d. Imposition of fine up to a specified amount. e. Expulsion/rustication from school in rarest of rare cases. f. The option of transferring a student from one school to another school may also be looked into" will be 'REMOVED' as this particular part does not align with Section 16 and 17 of Right to Education Act, 2009 and Section 75 of Juvenile Justice Act, 2015.


