As you are already aware that child wise data was collected first time during 2016-17 of more than 14.0 lakh student. District wise coverage of student and seeding of Aadhaar is as under;

Now, Student data for the year 2016-17 has been freezed by GOI. During Feb. 2017, we have got updated module from NIEPA to add new student and track the existing children for 2017-18. But as of now only 60% data of the student could be updated. Govt. of Himachal Pradesh and union govt. reviews the progress the seeding of Aadhaar of the student on periodic basis and have concern about the slow progress of the same. The Districts wise progress as of 15-7-2018 is as under :

Without promoting/updating the student, Aadhaar updation is not possible. It is therefore requested to provide issue necessary instructions to schools who have not updated and where the pace is slow through your Dy. Directors.

Moreover, the new guidelines of Samagra Shiksha Abhiyan (SSA) emphasises option of Cash transfer in the form of DBT to Aadhaar linked bank accounts of the beneficiaries for all types of child entitlements. Therefore, SDMS becomes more important wherein Aadhaar is seeded in the child database.
