Regarding Stringent Measures to be taken to Ensure Protection of Children from Sexual Offences.

In the recent past, there has been an incident of heinous crime against minor girl reported by Deputy Director of Higher Education, District Sirmour, wherein it has been intimated that a person tried to outrage the modesty of minor girl of 6th standard while she was on way to School. Such incident warrants stringent measures to be taken to ensure protection of children from sexual offences and to avert / prevent such incidents / crimes in future. To provide safe environment in Schools congenial to teaching learning and to curb such incidents in future, the following guidelines as are enumerated hereinafter be indispensably followed:-

 Sensitization programmes in the Morning Assembly to educate and sensitize the School students / children should be organized regularly.

Teachers, School Management Committees / Private School Management Committees, Parents and every stake holders of the education system may be sensitized. If any incident (s) of Sexual abuse, comes to the knowledge of any of the stakeholders or the common person or general public at large, POCSO Act casts duty on such persons to report such incident to the authorities concerned, immediately.

Spreading awareness about the provisions of this Act will help to prevent such offences against children and enable timely action to protect children from sexual abuse and exploitation. All the provisions enshrined in the Act ibid may be strictly followed by all the Government as well as by the privately managed Educational Institutions, failing which stern action will be taken against the defaulters.

Self defense life skills especially to girl students may be imparted in Schools to deal such challenges and also to promote physical, mental and emotional well being.

In the Morning Assembly students should be given tips about self protection by way of sharing experiences especially to girl students. The students may be guided to move to their School and back to home in groups.

Parents / guardians should be guided and sensitized about the security of their wards. The security issues should be discussed during monthly meetings of School Management Committee and teachers. The School Management Committee should also discuss the

P IT Cay protection issues in the meetings and ensure the security of students, particularly of girl students in and outside the school premises.

Child toll free No. 1098 should be conspicuously displayed in the school at prominent places
and students should be trained to contact this number in case of any emergency and difficult
circumstances.

- 8. Government of India, National Commission for Protection of Child Rights has launched the online solution "e-box" for redressing grievances related to POCSO. The NCPCR 'e-box' button shall enable the children/ students to lodge online registration of grievance pertaining to sexual offence committed against any child. It enables the children/ students to register their complaints in a simplified manner by visiting NCPCR website (<a href="http://www.ncpcr.gov.in/">http://www.ncpcr.gov.in/</a>) and click on e-box. Therefore, maximum children and other stakeholders may be made aware of this facility. It is also directed that this link regarding e-box may be displayed on the entrances, all notice boards and in the class rooms of the schools mandatorily.
- 9. The students/ children must be encouraged to report such case(s), if any, to Principal, Chairperson of Sexual Harassment Committee, Class Teacher or their Parents whoever they feel easy to approach. No such case(s) may be hidden at any cost by any person/ official concerned who have the knowledge of any such incident(s).

Apart from above, all the Deputy Directors of Higher Education in the State are also directed to ensure strict compliance of aforementioned guidelines in all Educational Institutions in their respective District and will also send the compliance report to this office, immediately.

The instructions mentioned hereinbefore must be adhered to and implemented in letter and spirit. Any laxity in this matter will be viewed seriously.
