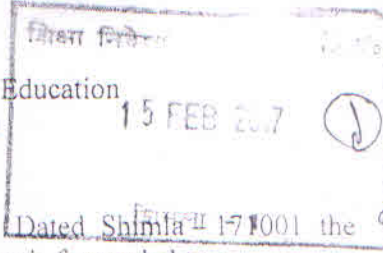

Issue of Scheduled Castes and Scheduled Tribes Certificates - Verification of Scheduled Castes and Scheduled Tribes certificates - clarification regarding caste certificates to the members of Scheduled Caste who have embraced Buddhism.

Sir,

I am directed to refer to this department's letter No.Per(AP-II)F(4)7/75, dated the 25<sup>th</sup> April, 1975, the 16<sup>th</sup> July, 1975 and letter No.Per(AP-II)F(10)-2/82, dated the 28<sup>th</sup> December, 1984 vide which the guidelines for issuance of caste certificate to the members of Scheduled Castes & Scheduled Tribes and revised form for issuance of caste certificate were issued/circulated.

2. Pursuant to the amendment of Constitution (Scheduled Castes) Order 1950 by the Constitution (Scheduled Castes) Order (Amendment) Act, 1990, the Scheduled Castes communities which are included in the Presidential Orders and converted to Buddhist religion shall be deemed to be a member of Scheduled Caste. Therefore, while issuing Scheduled Caste certificate to these persons the same procedure has to be followed as applicable to the members of other Scheduled caste communities belonging to Hindu and Sikh religion. The form of caste certificate will also remain the same as applicable to other Scheduled Caste communities (Annexure).

3. All the certificate issuing authorities are, therefore, requested to follow the above procedure for issuing Scheduled Caste certificate to the persons professing Buddhist religion provided:

- (a) the name of the community for which Scheduled Caste certificate is to be issued is included in the Presidential Orders specifying the Scheduled Caste in relation to the State of Himachal Pradesh;
- (b) that the person and his parents actually belong to the community claimed;
- (c) that the person belongs to the State and to the area within the State in respect of which the community has been scheduled;
- (d) the person claiming to be Scheduled Caste professes either the Hindu, Sikh or the Buddhist religion;

4. The instructions mentioned in para-1 above are modified to this extent and the certificate issuing authorities are requested to ensure proper verification before issuing such certificates. These instructions may be followed in letter & spirit and brought to the notice of all concerned for strict compliance.
