


Regarding ill Effects of misuse of Smart Phones by the Students in Schools.

This is with reference to the letter No.CWC/SLN/866/2019 dated 02-05-2019, Chairperson, Child Welfare Committee, Department of Social Justice & Empowerment, District Solan, has requested to issue standing instructions to all the Schools to refrain the Students from carrying Smart Phones in the Schools. In addition, regular search should be carried out in the School by the authorities and if any Smart Phone is found, it should be confiscated. Attention has been invited towards the fact that Smart Phones are generally used by the Students to access porn materials easily available on the web.

In this regard, you are directed to ensure that there should be strict vigil regarding the misuse of Smart Phones by the Students in the Schools. Students should be sensitized about the harmful / ill effects of misuse of the Smart Phones and inappropriate usage of internet. The Head of the Institution as well as Teachers will ensure that the instructions in this regard are carried out properly to all the Students. Special lectures / seminars etc. should be organized to sensitize the Students about the issue of misuse / excessive use of Smart Phones and internet.
