dated 16-02-2019 received from the Secretary (Education) Himachal Pradesh, on the subject cited  
above.

It has come to the notice of the Government that the SMCs of the concerned  
Institutions in Elementary and Higher Education has engaged teachers contrary to the provisions of  
SMC Policy notified on 17<sup>th</sup> July, 2012 amended from time to time. By doing so, unqualified teachers  
have been engaged and such teachers have approached the Hon'ble High Court Hon'ble HPAT to  
release Grant-in- Aid to their favour.

In view of position therefore, you are directed to go through the documents  
and do the needful as per direction received from the Secretary (Education) to the Government of  
Himachal Pradesh vide letter No. WDN-C-A(4)1/2011-V-L, dated 16-02-2019.

The action in matter may be taken on top priority bases. In case of any laxity  
in the matter head, of Office/Institutions/Dealing Assistant who deal the matter will be held  
responsible for such lapse and disciplinary action under rules will be initiated against him. Besides,  
explanation of all the Head of Institutions be called who have accepted joining of SMC provided  
teachers contrary to the provisions of SMC Policy such as unqualified teachers for the respective  
posts.

Sir,

It has been come to the notice of the Government that the SMCs of the concerned Institutions in Elementary and Higher Education has engaged teachers contrary to the provisions of SMC Policy notified on 17<sup>th</sup> July, 2012 amended from time to time. By doing so, unqualified teachers have been engaged and such teachers have approached the Hon'ble High Court/Hon'ble HPAT to release Grant-in-Aid their favour.

It has been provided under Clause 7 of the SMC Policy that "the Head of the Institution after verifying all the credentials, which include educational certificates as per R&P Rules and instructions issued by the Government, character certificates issued by the competent authority etc. will accept the joining of the said candidates(s)".

Clause 11 of the Policy provides that "the Grant-in-Aid is permissible only In favour of those Teachers, who have been provided by the SMCs after following these terms and conditions only".

The above terms of the SMC Policy makes the position clear that Grant-in-Aid is permissible only in favour of those teachers who have been provided by the SMC after following the terms and conditions.

In view of position stated above, you are, requested to issue instructions to all Heads of the Institutions that terms and conditions of SMC Policy are followed strictly and the Head of Institution must ensure that no teacher

has joined his Institution contrary to the provisions of SMC Policy. If such incident is brought to the notice of department/Government, the concerned Head of Institution shall be held responsible for such lapse and disciplinary action under rules will be initiated against him.

Besides, explanation of all Head of Institutions be called who have accepted joining of SMC provided teachers contrary to the provisions of SMC Policy such as unqualified teachers for the respective post.
