Subject: Regarding recovery of subscription under GIS Scheme 1984.


Sir,

The Government of HP decided in early 1990s to do away with accounting in paisa by rounding off the amounts to rupees. However, the GIS subscription from class IV employee continued to be Rs.4.5 for Insurance Fund & Rs.10.5 for Saving Fund. The department has rolled out the new OLTIS application from 1st April, 2016 throughout the state where paisa is rounded off at different stages leading to errors in Accounting, reporting & deduction etc.

Therefore, the matter was under the consideration of the Govt. and it has been decided that in order to facilitate accounting under the scheme, the total amount of subscription recoverable in these case should be in the whole rupee. Accordingly, the existing rates of recovery of subscription from Class IV employees under the Himachal Pradesh Government employees Group Insurance Scheme-1984 i.e. Insurance Fund Rs.4.5 & Saving Fund Rs 10.5 shall be replaced with new rates of Insurance Fund & Saving Fund at Rs.5 & Rs.10 respectively.

It is therefore, requested that all DDOs under your control may be directed to make recovery as per the revised rates.






