In this connection, it is stated that National Scholarship Portal does not have provision to accept the Scholarship application below 35% marks in connection with previous class percentage.

Therefore, you are directed to ensure that Students should have passed previous class with 35% marks which is mandatory for applying Scholarship under various Schemes.

Keeping in view of pandemic COVID-19, all colleges, where SC, ST, OBC Category students are applying for Scholarship will upload previous class /Percentage marksheet.
