

In continuation of this Directorate letter of even no dated 11th Oct, 2017 on the subject cited above vide which you were directed that all the schools should open their Mid Day Meal Scheme Joint Saving Bank Account in nearby Nationalized Banks/ HP State Cooperative Banks after completing all codal formalities.

In this regard, you are once again directed to issue necessary instructions to all the schools to implement the above said directions in letter and spirit, so that the unnecessary wastage of teaching time of teachers and students as well as unnecessary delays in providing funds for Mid Day Meal Programme in schools could be avoided in the interest of the teaching of students in the State. It is also directed that all the transactions should be made through RTGs /NEFT (E-Transfer) in respect of payment of honorarium to cook cum helpers and purchase of ingredients etc to local vendors. Action taken in the matter may be intimated to this office accordingly.

This may be treated as most urgent and personal attention be given for this purpose.
