

ORDER

Whereas considering the need to prevent any potential rise in number of cases in view of festive season, I. Raghav Sharma, IAS, District Magistrate-cum-Chairperson, DDMA, Una, in exercise of the powers conferred upon me under Sections 33 and 34 of the Disaster Management Act, 2005 and in welfare of the public at large, do hereby order and direct that the COVID-19 testing team of the Health Department shall be authorized to conduct the COVID-19 testing of any person for the purpose of preventing transmission of COVID-19 and such person shall comply with their directions for giving the sample. The COVID-19 testing team shall be authorized to have access to any premises, whether Government or private, for carrying out sampling for COVID-19 and any head of institution, whether Government or private, directed by them to cooperate in obtaining samples of persons present in that institution shall do so without demur.

Any person violating these measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act-2005 and all the Sub-Divisional Officers (C), Block Medical Officers, Tehsildars / Naib-Tehsildars will be authorized to initiate legal action under Section 60 of the Disaster Management Act, 2005.




