Memo,

As you are aware that the Government of Himachal Pradesh has notified scheme on " Structural Safety Audit of Life Line Buildings" on dated 29<sup>th</sup> September 2018, as per the provisions of Disaster Management Act-2005 to build a safer and disaster resilient state by initiating proactive prevention, mitigation and preparedness to ensure minimize loss of life, livelihood and property. The report of progress made in conducting safety audits of school buildings has to be submitted to the Government of India regularly at the end of each quarter under National Disaster Management Guidelines on School Safety Policy 2016.

You are, therefore once again directed to conduct the safety audits for structural and non-structural aspects of all school buildings of your District by 31<sup>st</sup> December 2021 positively. However it is pertinent to mention here that the structural safety audit is a purely technical achievement and it will be conducted by the technically sound person/ experienced Civil Engineer only with some hand held equipments in different steps.




