**OFFICE ORDER**

Reference to letter No. HFW-A-A (3) 1/2020 dated 14-3-2020 received from the Chief Secretary to the Govt. of H.P. and further conveyed by the Principal Secretary (Education) to the Govt. of H.P. letter No. EDN-B(14)-12/2018 Dated 14<sup>th</sup> March 2020 regarding instructions in view of COVID-19 and keeping in view the health and safety of students as a precautionary measure it has been decided by the Government and hereby further conveyed as below :-

1. All the Educational Institutions Govt. and private (Aided and Un-Aided), State Library Shimla, CSL Solan and all Distt. /Public Libraries/Teh. Lib/Trib. Lib and community Centre Lib of Himachal Pradesh shall remain closed with immediate effect till 31-3-2020.
2. Students will attend the school only to take/ appear in the Board Examination, Annual Examination and Assessment Examination etc. during March, 2020 as per the previous schedule.
3. All teaching and non-teaching staff members will attend the office as usual till further order.
4. Parents are advised to instruct their wards to avoid any large gathering /crowds during this period.
5. Students may also be advised to follow the Advisory / Instructions/ Guidelines issued from time to time by the Ministry of Health, GOI /GoHP and Department of Higher Education.
6. The students having common cold/flu /influenza and general fever etc be allowed special leave and their Practical/ Assessment Examination be adjusted in such a way that he/she may not come in contact with other students and his/her parents be advised to follow the advisory regarding such matter.


