Please find enclosed herewith a copy of letter NO.CWPIL No.146/2017-3517-Dated: 21.3.2019 received from the Addl. Advocate General, Himachal Pradesh, Shimla through the Under Secretary (Education), to the Government of Himachal Pradesh, Shimla-2 on the subject cited above.

In this connection, it is to inform you that the Hon'ble High Court has given directions in CWPIL No.-146/2017-Court on its own motion Vs State of H.P. & ors on dated: 21.02.2019:-

That the Jan Manch can be organized in the premises of Schools/Colleges/Any other Educational Institutions at various places on Sundays or Gazetted holidays. However, the prohibition imposed by this Court in exercise of PIL jurisdiction in respect of other kind of function shall continue to operate. It goes without saying that wherever the District Administrative is able to find out an alternative site to organize such function, the premises of the school may be exempted.

You are, therefore, hereby directed to go through the contents of CWPIL No. 146/2017-dated: 05.01.2019 passed by Hon'ble High Court and take further necessary action in the matter accordingly.
