Subject: - **Awareness regarding National Education Policy, 2020 (NEP-2020).**



You are, therefore advised to create awareness regarding the National Education Policy, 2020 (NEP-2020) among teachers, students, officials, parents, communities and other stakeholders in the School and Higher Education Systems by initiating discussion, debate, organizing webinars, seminars and various kinds of online and offline activities in this regard.
