Subject:- Delegation of financial power(s) and revision of economy instructions.

Sir,

With a view to effect economy and reduce unproductive expenditure, reduce procedural delay(s) and gear-up efficiency in administration at all level(s) in Government, comprehensive instruction(s) regarding delegation of financial powers were issued by the Finance Department vide its instruction of even number dated 03.06.2014 delegating thereby the financial powers to the Administrative Departments, Head(s) of Department(s) and Senior-most District level Officer(s) under all the SOEs. It has been made quite clear in these delegation(s) under SOEs "Salary" & "Wages" that neither creation of any new post nor filling up of existing vacant posts by any mode of recruitment is permissible except with the prior concurrence of Finance Department and approval of the Council of Minister(s). As sequel to it, the proposal(s) involving even creation of supernumerary posts for a specified/limited period(s) are being placed before the Council of Minister(s) for approval after seeking prior concurrence of Finance

Department by the respective Administrative Department(s) which is, indeed, not in the overall interest of administrative convenience. After due consideration, it has thus been decided that henceforth there is no need to seek the prior approval of the Council of Minister(s) in the cases involving creation of supernumerary posts in any Department of the Government. However, the prior concurrence of Finance Department on case by case basis in such proposal(s) would be mandatory as heretofore.
