I am directed to say that in terms of Jammer Policy of Government of India (uploaded at www.cabsec.nic.in/circular-policy-jammers.php), after evaluation by a Committee of technical experts through laboratory tests and field trials, competent authority has approved room cell phone jammer model EC-SJ-555B1 of M/s ECIL as an approved model for deployment in examination halls by statutory examination conducting bodies to prevent cheating through RF based devices.

2. Performance of the jammer model may be verified before deployment as effectiveness of the jammers depends on various factors like its power output, signal strength of BTS, traffic load on BTS at a given point of time, distance of jammer from BTS, sensitivity of receiver, terrain, topography, line of sight etc. The effectiveness of jammers deployed at different examination centres should be checked well before commencement of examination.
3. On specific request in this regard, details of the evaluation report can be shared by this office.
4. Actual deployment of jammers will require prior permission of Secretary (Security) in terms of jammer policy of the Government of India.
