In response to the COVID-19 situation, Government of Himachal Pradesh has launched e-Learning program 'Har Ghar Paathshala' to ensure continuity of students learning from home. Primarily, it is a WhatsApp-based initiative wherein State Project Office disseminates e-content to teachers, who in-turn disseminate daily learning e-contents in the form of videos and worksheets to the guardians of the students. For this purpose WhatsApp groups of all the educational institutions have been created to facilitate online teaching-learning. However, there's a darker side to WhatsApp. A growing number of legal cases involving bullying or harassment have stemmed from conversations that have taken place on WhatsApp.


It is therefore directed that in the official WhatsApp groups only departmental information, educational content etc. should be shared and other irrelevant and objectionable messages/videos should be strictly avoided. 


