Sub: - *Regarding Centrally Sponsored Scheme of Pre-Matric Scholarship for Schedule Caste Students Studying in classes 9th & 10th - Continuation of the scheme from the year 2017-18 to 2019-20 with modifications.*

Memo,

The Government of India have decided to continue the Centrally Sponsored Scheme of Pre-Matric Scholarship for Schedule Caste Students Studying in classes 9th & 10th from the year 2017-18 to 2019-20 (coterminous with Fourteenth Finance Commission Cycle) with the following main modifications effective from 19th September 2017.

- (i) The Parental/Guardian's income stands enhanced from Rs. 2.00 Lakh to Rs. 2.50 lakh per annum.
- (ii) The benefits of National Means-cum-Merit scholarship scheme of D/o School Education, Ministry of Human Resource Development can be also availed by the beneficiaries of Pre-Matric Scholarship Scheme for SC students.
- (iii) In pursuance to the provision of session 7 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act 2016, Aadhaar enrolment has been made necessary.
- (iv) Revised rates of scholarship will be as follow:

- (v) Procedure for online application for scholarship on the respective State/UT scholarship portal has been added in para-12 of the existing guidelines.
- (vi) Committed liability has been redefined.
- (vii) Procedure for claiming and release of Central Assistance in the para 16.1 has been slightly modified.
- (viii) Following para have been newly added in the existing scheme guidelines:
 - (a) Effective implementation alteration in modalities.
 - (b) Evaluation
 - (c) Transitory provision for existing beneficiaries.

In this regard, you are directed to issue instructions to all the Principal/Headmaster of GSSSs & GHSs to apply online through our website i.e. hpepass.egg.gov.in as per modify income limit and scholarship rates.
