Linking & Uploading of Educational Certificates, Income Certificate, Caste Certificate and Bonafide/ Domicile Certificate with the Aadhar Number of the Students and Maintaining of Data in the Digilocker, reg.

Your kind intention is invited to this Directorate letter of even number dated 04-09-2021 vide which it was brought to your kind notice that Ministry of Social Justice and Empowerment, Government of India has circulated revised guidelines under Centrally Sponsored Post-Matric Scholarship Scheme for SC Students. As per revised guidelines of scheme envisaged a robust IT Framework that, seamlessly and on real-time, verifies the eligibility upon entry of the Aadhar Number of the student in the registration page by autocheck of the online database of the (a) Income Certificate, (b) Caste Certificate, (c) Domicile Certificate and (d) Educational certificate/mark sheet of the candidate. This requires uploading & linking all the certificates issued by the concerned authorities in the State and thereafter uploaded in the Digilocker, on a real-time basis, which must be linked with the Aadhar number of the student. This will eliminate the vexatious process of

manual verification of the scanned /pdf certificates by concerned authorities which invariably delays the process of sanction of the scholarships under centrally and state sponsored scholarship schemes.

In this context, all the above stated authorities are requested that educational certificates and other certificates i.e. (a) Income Certificate. (b) Castc Certificate, (c) Domicile Certificate etc. may be linked with Aadhar number of the students/ applicant and must be uploaded in the digillocker, so that it could be linked with National Scholarship Portal through scamless APIs for the ventication and sanction of scholarship under centre and state sponsored scholarship schemes.
