Regarding Annual income certificate required for various centrally Sponsored Scholarship Scheme.

It has come to the knowledge of undersigned that majority of students claiming scholarship are uploading income certificate issued in their name. As per Centrally Sponsored Scholarship Scheme guidelines income certificate should include income of parents only. If both the parents are not alive then income certificate of guardian shall be uploaded. In case of PM YASASVI scholarship scheme for OBCs/EBCs/DNTs if students is employed income of parents and applicant will be taken into consideration.

Income certificate issued on the basis of family income may render some of the eligible applicants ineligible as annual income of parents may not be exceeding 2.5 lakh, however family income may exceed 2.5 lakh. Therefore, students should upload income certificate as per respective scholarship scheme guidelines. Institutional Head should verify scholarship application strictly as per scholarship scheme guidelines.

Income certificate issued by competent authority as per scholarship scheme guidelines will be strictly adhere to from next academic session i.e. 2023-24. Therefore, Head of institutions should make aware the students and their parents/guardian by organising awareness campaign and through PTA/SMC executive and members and with the assistance of NSS volunteers.


