Sir,

You may be aware that the Directorate of Women and Child Development, Himachal Pradesh is running Bal/ Balika Ashrams (Child Care Institutions) itself or through the NGOs under Juvenile Justice (Care and Protection of Children) Act, 2015 for providing residential facilities to children in need of care and protection and the children in conflict with law. Functioning of these Child Care Institutions and implementation of the aforesaid Act is monitored by the Hon'ble Juvenile Justice Committee of Hon'ble High Court of Himachal Pradesh on quarterly basis. Mr. Justice Tarlok Singh Chauhan, Judge, Hon'ble High Court of Himachal Pradesh is the Chairperson of aforesaid Committee.

It has come to the notice of Hon'ble Mr. Justice Tarlok Singh Chauhan, Chairperson of the Hon'ble Juvenile Justice Committee that the children living in Bal Ashram Sarahan, Tehsil Rampur, District Shimla use to threaten the staff of the Ashram and the teachers of Senior Secondary School Sarahan, when they are asked to attend the school regularly and maintain discipline in the Ashram as well as school by saying that they will complain to Mr. Justice Tarlok Singh Chauhan, Chairperson of the Hon'ble Juvenile Justice Committee. Mr. Justice Tarlok Singh Chauhan has condemned the undue pampering of children and has directed that strict discipline be maintained in the schools and the children of Bal/ Balika Ashrams running through out the State be motivated through the Principals/ Teachers to attend the schools regularly. They may also be counselled to avoid drugs.

In view of the above, it is requested to direct the Deputy Directors of Higher/ Elementary Education to take further necessary action in the matter accordingly under intimation to this Directorate. This may be treated as Most Urgent.
