Sir,

Please refer to the letter No.Shiksha-II-Gab(1)2/2009-I-Ldated 01.07.2017, 2017, received from the Addl. Chief Secretary (Education) to the Government of Himachal Pradesh. Vide which he has send a photo copy of D.O.No.11024/1/2016-SCD.I dated 15.06.2017(along its enclose) received from Secretary to the Govt. of India Ministry of Social Justice and Empowerment of Social Justice and Empowerment Shastri Bhawan, New Delhi-110001on the subject cited above.(copy enclosed)

In this regard it is intimated that the Department of Social Justice Empowerment G.O.I proposes to introduce a Centrally Sponsored Scheme of "Residential Schools for Schedule Caste girls" studying in classes VI to class XII, where in 70% of seats are reserved for Scheduled Caste girls whose parental income is less then Rs.2.5 Lakh per annum and remaining seats would be open to BPL girls of other categories and communities. The residential schools would be opened in educationally backward districts with large Scheduled Cast population.

As the matter regarding Centrally Sponsored Scheme has already been dealt in the RMSA/SSA.H.P. and 5 model schools established in educationally backward blocks under centrally sponsored scheme i.e 4 model school in Distt. Chamba & I model school in Distt. Sirmour has also been dealt in your office as Govt. Notification No EDN-B-Ga(10)-2/2010-III dated 29.04.2014 & dated 3rd May 2014.(copy enclosed).

In view of the above position you are, therefore requested to prepare the proposal of Residential Schools for Schedule Caste girls under Centrally Sponsored Scheme as per Broad outline /guideline of the proposed scheme of setting up of " Residential Schools for SC girls" given by the G.O.I and further submitted to the Govt. for taking approval in this matter under intimation to this Directorate.
