Sir/Madam

As you are already aware that two sets of free School uniforms are being provided by the Government to all the HP Govt. School students classes 1st -10th (Boys & Girls) under " Mahatma Gandhi Vardi Yojna" including stitching charges @200/- per student per annum.

In this context, it is stated that the entire supply of ordered quantity which was on the basis of enrollment collected from all the DDEE/DDHE of free school uniforms under "Mahatma Gandhi Vardi Yojna" for the year 2017-18 has been completed by the supplier firm to all the Identified Indenting Officers of the Education Department(126 BEOs & 124 Principals). You are therefore directed to apprise this office that whether the two sets of free school uniforms and stitching charges have been distributed to all the HP Govt. School students classes 1st-10th (Boys & Girls) under the aforesaid yojna. You are further directed to apprise this office about the requirement of additional sets of free School uniforms if any to this Directorate under "Mahatma Gandhi Vardi Yojna" within a week period, so that the HPSCSC is requested to supply the additional sets of free school uniforms to the respective Indenting Officers in time. In case there is no requirement of additional sets of free school uniforms under the said yojna for the year 2017-18 Nil information may be intimated to this office within abovesaid stipulated time.

In this context, it is pertinent to mention here that if any students (Boys & Girls) are left without free school uniforms and stitching charges under the abovesaid yojna responsibility of the erring officers/officials shall be fixed and stern disciplinary action shall be taken against such officers/officials as warranted under the rules and no further demand of additional free school uniforms will be entertained after the lapse of abovesaid one week stipulated period.


