Memo: Enclosed please find herewith photocopy of D.O. letter No.1-7 /2019-
18.5, Dated 06-11-2019, along with the enclosures received from the Ministry of Human
Resource Development, Government of India, through the Principal Secretary (Education) to
the Government of Himachal Pradesh regarding the subject cited above.

In this regard it is to inform that the Government of India has issued
detailed guidelines for the activities to be conducted under "Ek Bharat Shreshtha Bharat"
programme in schools. Himachal Pradesh has been paired with Kerala for implementation of
this programme. These activities will lead to the enrichment of knowledge of the partnered
state and also develop a sense of bonding between the students of partner state. These
activities should be integrated in regular school activities without any need of extra classes/
periods and funds/ infrastructure.

Under this programme "EBSB" Club should be constituted in every
school, having of students as members and the members of club should meet at least once in a
week. The aim of this club shall be to propagate language, culture of the paired states through
the activities suggested in the guidelines enclosed herewith.

Therefore you are directed to ensure the implementation of these
guidelines from the field functionaries in letter and spirit. You are further directed to identify
and nominate Nodal Officer/ Coordinator at District and school level and also to develop a
monitoring mechanism plan for the evaluation of these activities in Schools under your control.
The action taken report to be submitted to this office within a week itself.
