Subject:- Regarding head of account for RTI receipts.

Sir/Madam,


I am directed to refer to the subject cited above and to say that during workshop on PSG held on 15-05-2019 it has been noticed that some of the Public Authorities have opened their own head of account for RTI receipts. This practice is a violation of Rule 5(3) of RTI Rules, 2006, which is reproduced as under:

"Fees/Charges shall be deposited in a Government Treasury under the head of account "0070-OAS, 60-OS, 800-OR, 11-Receipt head under Right to Information Act, 2005". Accruals into this head of account may be placed in a separate fund by way of grant-in-aid for furthering the purposes of the Act including purchase of equipment and consumables, providing training to staff etc"

It is, therefore, requested that aforesaid provisions of Right to Information Rules, 2006 may be adhered strictly so that misappropriation of RTI receipts be avoided.

All Public Information Officers working under your control may be informed accordingly.
