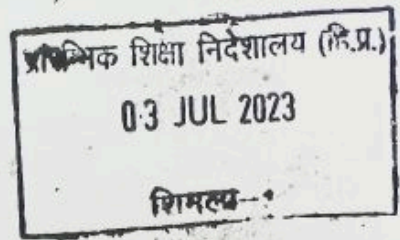

Subject:- Social Audit of Centrally Sponsored PM Poshan Scheme-reg.

Sir

It is bring to your notice that during the course of Social Audit of PM Poshan (MDM) Scheme, following major shortcomings are observed by the social audit team in the implementation of the scheme in schools in the State as under :

- MDM logo, Weekly menu, per child per day entitlement and Emergency / Helpline Nos are not displayed in school premises.
- Stock Register / Ledger Register not maintained in schools
- SMC's meetings not conducted in regular intervals.
- Cleanliness of school kitchen cum Stores & water tanks not maintained as per norms.
- Health Checkups of CCH's not conducted regularly i.e.(Twice in a year).
- MDM Teacher Incharge not rotated as per fixed norms i.e. (After Two Years).
- Separate toilets for boys & girls not available in some schools.
- Cleanliness of toilets not maintained as per norms.
- One month advance foodgrains (rice) not available in some schools.
- Safe & clean piped drinking water not available in some schools

In view of the above, you are requested to immediately take corrective measures to remove all above mentioned shortcomings at school level at the earliest and send the action taken report (ATR) to this office as per format given below. However, uniform specimen sample of MDM Logo, Weekly Menu format, per child per day entitlement and Emergency/ Helpline numbers for painting in prominent place of school premises is being enclosed herewith as per Annexure-I for which requisite funds have been made available to all schools through PFMS under MME component of PM Poshan Scheme.

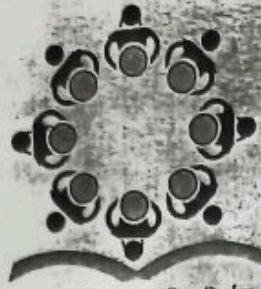
