Memo:

It is intimated that the above, mentioned COPCs filed by the different applicants were appeared before the Hon'ble Administrative Tribunal on 15.05.2018. The Hon'ble Court after hearing the matter took a serious view for non-compliance of orders passed in above quitted COPCs and directed the respondent No. 2 i.e. Director of Higher Education to remain present in person before the Hon'ble Court on 25.06.2018 to explain as to why the orders have not been complied. On said date undersigned and Joint Controller ( F&A) alongwith Supdt. Legal & Supdt. Library Branch of this Directorate as well as Supdt. DDHE, Hamirpur, Dealing Assistant DDHE, Bilaspur were present in the Hon'ble HPAT, none of the officers/officials of DDHE Kangra, Mandi & Sirmour were present in the Court on 25.06.2018. The Hon'ble HPAT on said date asked the Department that why the Court Orders /judgements dated 23.12.2015 and 15.05.2018 have not been implemented despite pay fixation orders issued by the Director of Higher Education. The Department has informed the Hon'ble Court that the pay fixation orders of petitioners have already been issued to all the DDOs of concerned institutions for taking further necessary action in the matters. The Department of Higher Education has also requested the Hon'ble Court to grant some more time for implementation of these orders as the applicants/petitioners have served in different institutions and due and drawn statements are being collected from their previous stations for preparation of bills and further disbursement of payments to them. The Hon'ble Court has granted some time for compliance of Court orders and directed to file compliance report before the Hon'ble Court on next date of hearing.

In this context, all the Deputy Directors of Higher Education are directed to issue the necessary direction to all concerned Principals/DDOs under the control of their respective Districts for compliance of pay fixation orders already

Supplied to all DDOs concerned in r/o Asstt. Librarians/Librarians as per list attached at Annexure-"A", "B", & "C" up to 10.07.2018 respectively and compliance report of

pay arrear released to these Assistant librarians/Librarians through RTGS and other mode of payment may be provided to this Directorate through special messenger on or before 12.07.2018.

Beside this the Deputy Director of Hr. Education, Hamirpur, Kangra & Mandi are again directed to comply the directions dated 19.06.2018 issued by this Directorate, vide which the information of pay arrear released to ex-serviceman posted /retired as Asstt. Librarian/Librarian as per list attached at Annexure-"A". The details of military services rendered after attaining the minimum age and educational qualification prescribed in the rules alongwith service book, discharge book, Annexure-"B" of military service, Educational Qualification Certificate and other details etc. may also be provided to this Directorate through special messenger on or before 12.07.2018, to ascertain their eligibility for granting the benefit of pay fixation in the light of instructions issued by the Govt. of H.P. on 30.01.2018. Failing which, you will be held responsible alongwith DDOs of concerned institutions. Any delay in the matter will be viewed seriously and defaulter Officers/officials will have to explain the reason of delay personally in the Hon'ble Court on next date of hearing.

In view of the above position it is also directed to all DDOs concerned that while preparing the arrear bills it may be ensured that whether applicant is actual petitioner or non-petitioner to ascertain this fact copy of CWP/O.A. may sought from the applicant/petitioner and arrear will be prepared as per instructions issued by the Govt./Department from time to time.

The complete information of those Assistant Librarians whose services were taken over by the Department vide taking over policy dated 20.07.2011 after new R&P rules of Assistant Librarians of dated 12.07.2010 may also be provided through special messenger to this Directorate on or before 12.07.2018.

Treat it as Most Urgent and personal attention may be given being a Court matter.
