
Subject: Police Verification of Driver/Helpers of Vehicles ferrying children to schools-reg.

In pursuance to Government of Himachal Pradesh letter No. EDN-C-F(10)1/2019 dated 16th September, 2019, received from Principal Secretary (Education) to the Government of Himachal Pradesh, on the subject cited above.

In this regard, in the light of various incidents of abuse of school-going children on the way to and back from schools, it has become necessary that all possible steps are taken to ensure the safety of school children during their journey to and from the school. An important step in this regard would be to have police verification carried out in respect of the drivers and helpers etc. of bus/van/auto-rickshaw ferrying school children.

In view of above mentined, you are directed to ensure that staff should be engaged for ferrying the school-children only after the police verification of their character and antecedent/Driving Licence ect. Apart from this, with the passage of time, a person may be affected by many psycho-social factors in his immediate or distant environment. It would therefore be desirable that the police verification is repeated after every two years, so as to ensure continued safety of the children in their journey to and from the school.

The Heads of all the private Schools are directed to strictly adhere to these instructions in letter and spirit, failing which stringent action will be taken against the school authorities.


