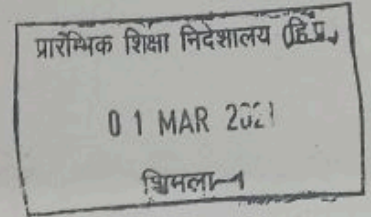

Sub: - Distribution of Food Security Allowance (FSA) to the eligible students under Mid Day Meal Scheme for the closure period of schools including vacations period (summer & winter both) in view of Covid-19 pandemic.

Sir,

In continuation of this Directorate letter of even No. Dated 20.03.2020 followed with reminder letters Dated 31.03.2020, 11.05.20, 15.05.20, 26.05.20, 12.06.20, 22.07.20, last being Dated 23-10-2020 vide which you were directed to distribute the Food Security Allowance (FSA) i.e. per day per child entitled quantity of foodgrains (rice) @ 100 gms for Primary classes & 150 gms for Upper Primary classes as well as per day per child entitled cooking cost @Rs.4.97 for Primary classes & Rs.7.45 for Upper Primary classes (or its equivalent pulses, oil etc.) to all the eligible school students under Mid Day Meal Scheme for the closure period of schools due to Covid-19 pandemic including vacations period (summer & winter both) as per Government of India directions.

In this context, your kind attention is also drawn towards this Directorate letter No. संख्या ई डी एन-एच (प्रारंभिक) (4) 4-1/2019-vacation दिनांक 07-02-2020 vide which you were directed to suspend the preparation & serving of hot cooked mid day meal to the eligible students under Mid Day Meal Scheme in all schools till 31.03.2021 in the State as a precautionary measure in view of safety & hygiene of the school students in view of Covid-19 pandemic.

In view of the above you are once again directed to ensure the distribution of per day per child entitled quantity of foodgrains (rice) and entitled cooking cost as Food Security Allowance (FSA) to all the eligible students under Mid Day Meal Scheme till 31.03.2021 including vacations period (winter & summer both) to meet the nutritional requirements of the children and in order to safeguard their immunity which is very vital during Covid-19 outbreak. In this regard, you also directed to provide

the information regarding distribution of Food Security Allowance (FSA) as on 31.12.2020 to this Directorate on the prescribed formats enclosed at Annexure-I & II also furnish the certificate to this office as per Specimen attached at Annexure-III with your signature & Seal certifying that the per day per child entitled quantity of foodgrains (rice) and per day per child entitled amount of cooking cost as Food Security Allowance (FSA) have been distributed to all the eligible students under Mid Day Meal Scheme. However, similar certificates may also be obtained from all the BEEO's & CHT's working under your jurisdiction to this effect.
