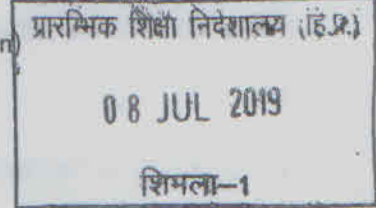

In this context, it is stated that as on date out of 15,499 schools 13,489 schools have filled up the requisite information online and 2010 schools have yet to fill up the online information in the instant matter as per district wise detail given below.

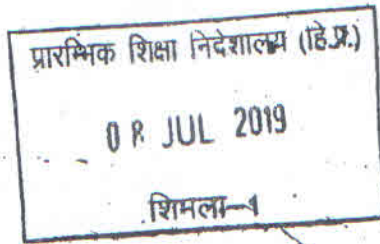

In view of the above you are therefore once again directed to issue necessary instructions / directions to all the left hand schools to fill up the requisite information within fortnight. The information must be fill up carefully, properly and completely against each column of the above said approved format for evaluating mid day meal programme, since the mid day meal programme is being evaluated by the Hon'ble supreme court in all the states from time to time. The respective schools have to fill up the form properly and completely at school level or get it filled at nearest GSSS/ GHS or at BEEO office on priority basis in a time bound manner. Non- Compliance of the Hon'ble Supreme Court orders ibid will be at your risk and responsibility and the defaulters will be liable for action under the rules.

This may be treated as most urgent, time bound, be given personal attention and top priority being Hon'ble Supreme Court order.
