Utilization/distribution of surplus free school uniform sets under "Mahatma Gandhi Vardi Yojna" (classes 1st -10th) and "Mukhya Mantri Vardi Yojna" (classes 10+1 & 10+2) for the year 2017-18.

Sir,

It is stated that on the basis of information collected from all the DDEE's/DDHE's regarding the number of surplus school uniform sets due to migration and shifting of students to private schools under "Mahatma Gandhi Vardi Yojna" (classes 1st -10th) and "Mukhya Mantri Vardi Yojna" (classes 10+1 & 10+2) for the year 2017-18, 10,655 surplus school uniform sets under "Mahatma Gandhi Vardi Yojna" (classes 1st -10th) and 12,835 surplus school uniform sets under "Mukhya Mantri Vardi Yojna" (classes 10+1 & 10+2) are lying with various Indenting Officers i.e. 124 Identified Principal of GSSS and 124 BEEO level in the State, district wise detail of surplus school uniform sets under "Mahatma Gandhi Vardi Yojna" (classes 1st -10th) and "Mukhya Mantri Vardi Yojna" (classes 10+1 & 10+2) are attached herewith at Annexure-I, II & III).

In this context, it has been decided by the competent authority that these surplus school uniform sets (Boys & Girls) of the year 2017-18 under "Mahatma Gandhi Vardi Yojna" (classes 1st -10th) and "Mukhya Mantri Vardi Yojna" (classes 10+1 & 10+2) lying with various Indenting Officer level i.e. at District/Block/ School level may be distributed among the poorest of the poor students of BPL/IRDP family students studying in Government School in the State. The decision regarding distribution of these surplus school uniform sets among poorest of the poor students of BPL/IRDP families will be taken by the "School Management Committee" of the concerned school and distribution process in this regard may be done in the presence of SMC's and parents of such school students. But, it is clarified that the stitching charges for the distribution of these surplus school uniform sets will not be given to such students. However, the total amount of unutilized/unspent stitching charges on account of surplus uniform sets lying with BEEO's/Principal's GSSS may be refund back to this office through draft/cheque at the earliest, so that the matter could be process further.

In view of the above, you are therefore, directed to take necessary action in the matter at the earliest and send the action take report/utilization certificate with regard to the distribution/utilization of surplus school uniform sets of the year 2017-18 under "Mahatma Gandhi Vardi Yojna" (classes 1st -10th) and "Mukhya Mantri Vardi Yojna" (classes 10+1 & 10+2) may be send to this office accordingly on priority.

This may treated as most urgent and time bound.
