

Subject: - Submission of status report regarding installation of Sanitary Napkin Vending Machine WPIL No. 2455/2017 titled as M/s Prem Mohini Gupta Vs. State of H. P. and Ors.-Explanation thereof.

In continuation to this Directorate letter of even number dated: 12/12/2018, 04.01.2019, 22.02.2019, 28.02.2019, 13.03.2019, 20.04.2019 and 27.04.2019 on the subject cited above.

Some matters are required to be taken up with the Government and Hon'ble High Court, Himachal Pradesh in a time bound manner, which could be considered and taken up only after the detailed reports and complete feedbacks from the field functionaries are received. In majority of the cases the necessary action is required to be taken at your end, and reports thereof are to be sent to this office, and these reports/feedbacks are never received in time. This manifestly implies that orders and directions issued by this Directorate are not being taken seriously by you and are dealt perfunctorily in cavalier manner. Due to non-compliance of orders, delay and dilly-dallying caused at your level, important time bound policy decisions are delayed. This has been viewed very seriously at the Government level, Hon'ble High Court and by the authorities in this Directorate.

You are once again hereby directed to issue strict necessary instructions to all the Heads of Private Educational Institutions (Schools) under your jurisdiction to install Sanitary Napkin Incinerators in their respective schools and the status report may be compiled at the earliest and supply the status report to this Office by 19th July, 2019 positively so that the reply could be submitted to Hon'ble High Court of Himachal Pradesh within stipulated period. If any Private Educational Institutions fails to obey the orders the


