Your kind attention is drawn towards this Directorate letter of even No dated 01-05-2017 and subsequent reminders dated 07-06-2017, 17-07-2017 and 26-08-2017 vide which you were directed to get filled up the requisite information on the prescribed format for every school online in respect of Mid Day Meal Programme in order to comply with the orders of Hon'ble Supreme Court issued in writ petitions (civil) 618 & 676 of 2013 Titled as " Antarrashtriya Manav Adhikar Nigraani Vs Union of India & Ors." In this context it is stated that as on date 11-10-2017 out of total 15,390 schools 14,803 schools have filled up the requisite information online and 587 schools have yet to fill up the online information in the instant matter as per the district- wise detail given below :-
