Apart from above, in case of non-availability of other teacher of the any subject, the Teacher of the concerned subject will be asked to join the duties for short period for preparing the notes / study material of his/her subject(S), if it is necessary to be supplied to the students at their home, keeping in view the interest and future of the Students. The online/ distance learning for the School Students shall be continued under the programme "Har Ghar Pathshala" and under "Himachal Doordarshan Gyanshala Programme".
