As per the decision taken in the meeting held on 03/06/2019 under the Chairmanship of Additional Chief Secretary (Health) to the Government of Himachal Pradesh you are hereby directed to issue instructions as under amongst all the educational institutions under your jurisdiction that :-

- There should be convergence between the functions of the school Management Committees and Anti Drug Vigilance Committees. Meetings should be organized in all educational institutions once every month. The RBSK Rashtriya Bal Swasthya Karyakram team should be invited to participate in such meeting.
- Active involvement of Private schools in Anti-Drug Campaigns may be ensured and regular feedback may be obtained.
- Visits by NCC officers along with cadets may be organized in Schools as NCC is <sup>an</sup> such activity which is reasonably preoccupying in nature and also inculcates the sense of nationalism in students.

Further you are hereby directed to issue necessary instructions to all the field functionaries to maintain the record of the meetings and the activities conducted and to comply with the instructions/directions issued from this Directorate in letter and Spirit and timely submit the Action Taken Report. Further, you were directed telephonically to provide the list of Nodal Officers appointed to look after the issue of Drug Abuse with name and Contact number to this Directorate. The information in this regard is still awaited till date which is a matter of great regret. You are therefore once again directed to provide the list of Nodal Officers at the earliest through return fax/e-mail. Further, it is also directed to submit

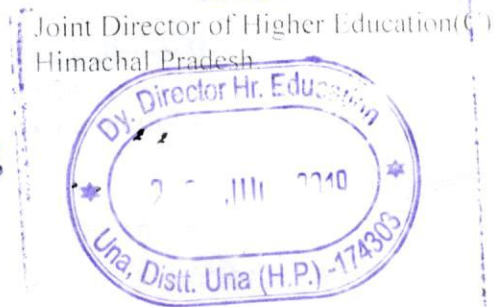
